



# Pre-Law Scholars Program

## PRE-PROFESSIONAL ADVISING

When applying to Ripon College, qualified applicants interested in pursuing a bachelor's degree and juris doctor degree can take advantage of Ripon's Pre-Law Scholars Program with one of our four partner schools: American University Washington College of Law in Washington, D.C.; Marquette University Law School in Milwaukee, Wisconsin; Mitchell Hamline School of Law in St. Paul, Minnesota; and University of St. Thomas School of Law in Minneapolis, Minnesota.

This unique 3-plus-3 program places qualified students on a fast-track program to earn their law degree one year sooner.

Ripon Pre-Law Scholars who have met all requirements will be able to apply to one of our partner schools during their junior year or after completing 95 credits at Ripon. Those who are admitted will move directly into one of these law programs. After Scholars have successfully completed all requirements during their first year of law school at American, Marquette, Mitchell Hamline or St. Thomas, they will be able to transfer any outstanding undergraduate credits needed back to Ripon to achieve a baccalaureate degree at Ripon College.

Scholars then will have two additional years of law school at one of our four partner schools before receiving their juris doctor degree. By receiving the J.D. in six years, most students will save a full year of college tuition.

In addition to saving time, Scholars can take immediate advantage of special networking events and planning opportunities with the respective law school during their first year at Ripon.

### COURSE REQUIREMENTS

- Admission to the Pre-Law Scholars Program is limited to incoming first-year students with a minimum score of 26 on the ACT test and a cumulative GPA of 3.65 or higher. Students may, however, apply to the program at anytime if they have a cumulative GPA of 3.50 or higher at the end of their first or second year at Ripon College. Students with a GPA lower than 3.50 will be considered if other aspects of their Ripon College academic record show a demonstrated level of success.
