____ 3. **2020 Healthcare Expenses:** Provide estimated figures for the entire year. \$ _____

- A. Include only those expenses you are allowed to report as "Itemized Deductions" schedule A even if you do not have enough to itemize. Examples: hospital care, lab fees, co-payments, deductibles, prescriptions, braces, etc.
- B. **Important: If you are self-employed and claim the cost of health insurance on line 29 (schedule 1) of the federal tax return, you may not include that cost on this application.**
- C. Do not include any expense that is or will be: reimbursed by insurance, paid with pre-tax dollars (referred to as a cafeteria plan, flexible spending account, health savings account, etc.), paid by your employer or billed in one year but paid in another.

- a. Example: The total of all bills received in 2020 for medical procedures, office visits, dental exams and prescriptions was \$9,000. Insurance paid \$4,000, and \$1,000 came from a pre-tax flexible spending account. Only the remaining \$4,000 "out of pocket" can be considered for financial aid purposes.

- 2020 federal tax return with Schedule A and all other applicable schedules
- Copy of paid medical expenses

4. Educational Expenses
